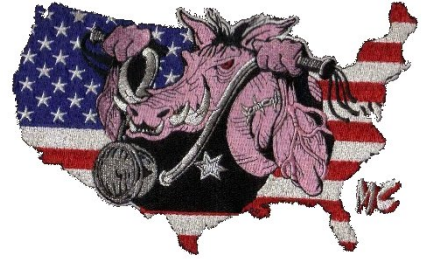

The **LAW RIDERS MOTORCYCLE CLUB** is an independent organization not affiliated or sponsored by Harley Davidson, INC. The club was instituted to offer motorcycling benefits and services to the Public Safety Sector and Law Enforcement officers. The goal is to generate an increased level of enthusiasm for riding Harley Davidson motorcycles while at the same time recognizing individual interest for all types of motorcycles.

The **LAW RIDERS MOTORCYCLE CLUB** is a non-profit organization.

All members pay yearly dues of \$30.00 due in July of each year. These dues cover all club expenses for the year. Dues, application and membership fee are non-refundable.

You are required to attend three meetings and/or events, such as a ride before your application can be approved. A club sponsor will be assigned to you.

There is an application fee (\$50); this will cover the cost of your first year dues and application process. The membership fee (\$50) is used for club expenses of colors. After your application is accepted, and the monies paid, you will receive the "LAWRIDERS", club chapter name tabs, and the American Flag for the front of your vest. No other patches or pins will be allowed on the vest until the probation period is completed. After passing probation (6) months, (one year for Associate members), you will receive the remainder of the patches for the rear of your vest. Probation is to establish your willingness to participate in the club, events and to support our common goals.
